Primary objective is long-term capital appreciation, with income generation as a secondary consideration. The Fund is willing to assume moderate to high risk commensurate with the expected returns.

The fund prioritizes long-term growth and diversification through a highly active approach, investing in a balanced portfolio of European investment-grade bonds and equities.

The equity strategy combines the systematic insights of the "Berenberg STOCKPICKER Model," identifying undervalued, resilient companies, with the manager's "European Equities Selection Strategy," reflecting high-conviction fundamental research and a focus on dynamic growth.

To further manage volatility and enhance diversification, particularly in extreme market phases, the Fund may invest in other asset classes. Currently, a small portion of the equity portfolio is allocated to a selection of high-quality Bergos-Berenberg Funds, chosen for their dynamic and promising performance profile, allowing the Fund to capitalize on diverse market segments and investment opportunities across Europe.

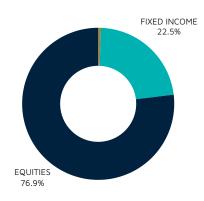
